

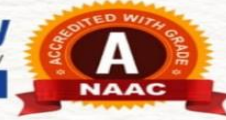

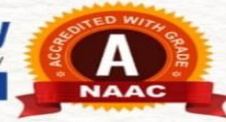

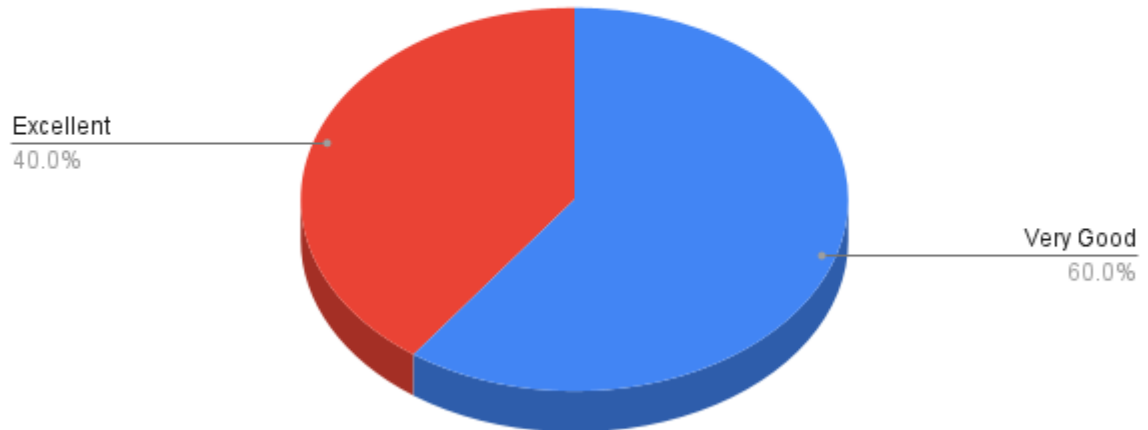

Graph 9: 40% employers give both excellent and very good opinion. 20% employers give good comments about the abilities of the curriculum in developing practical solution to workplace problem.

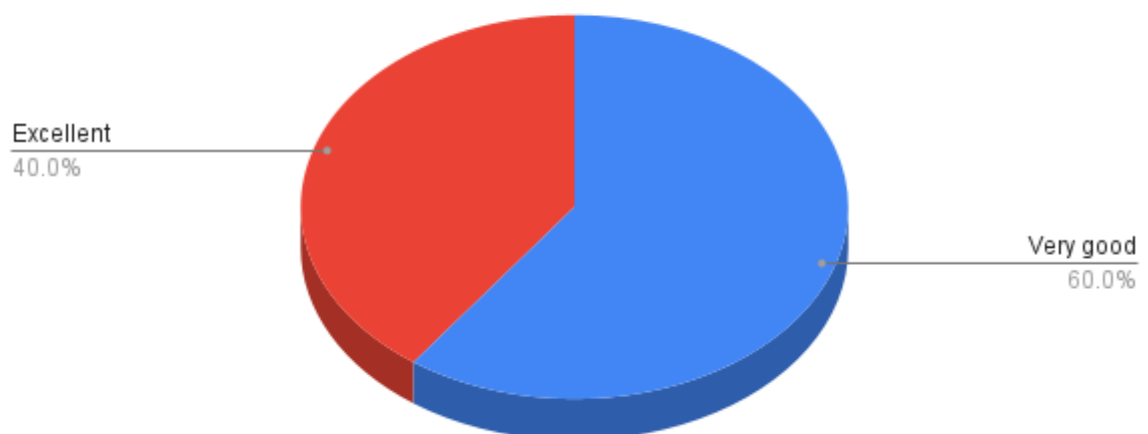

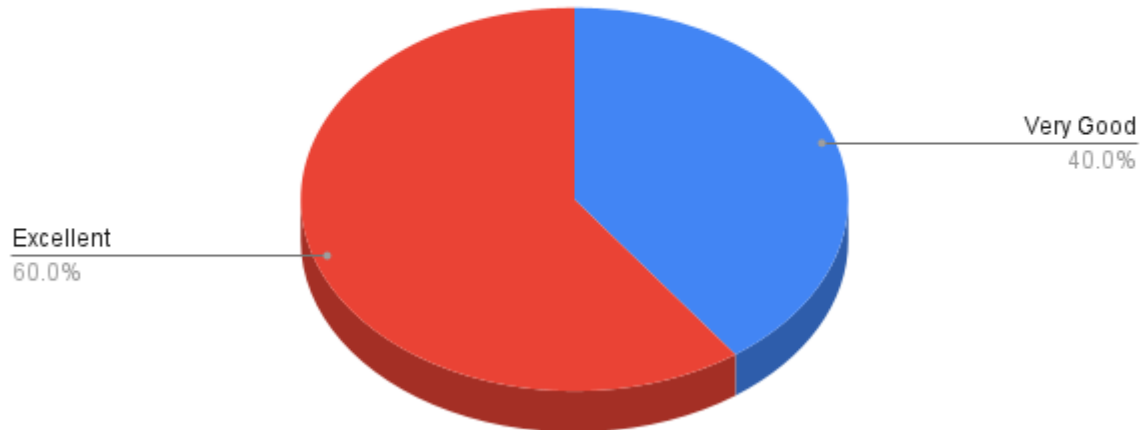


How do you rate the promised competencies/outcomes of programmes in relation to industrial needs?

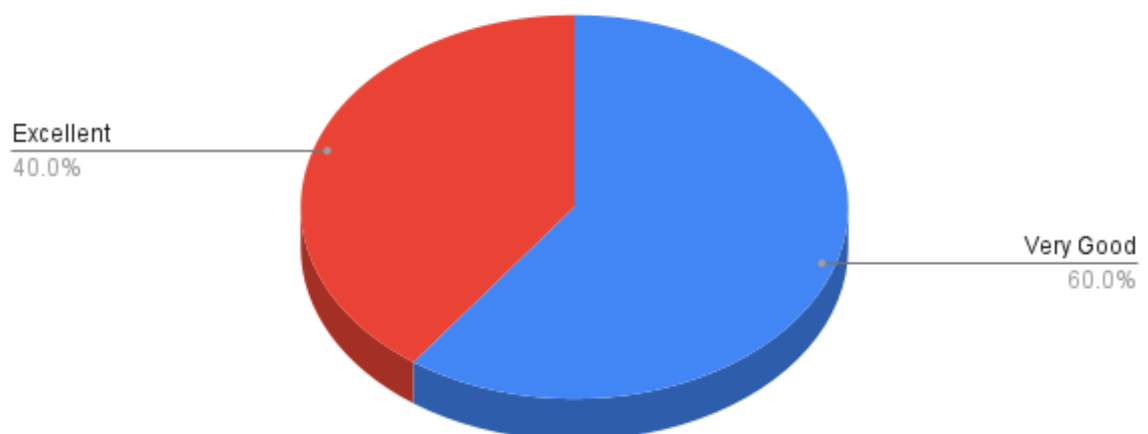


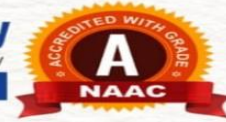


How far the curriculum helps your employees to improve their planning and organization skills?

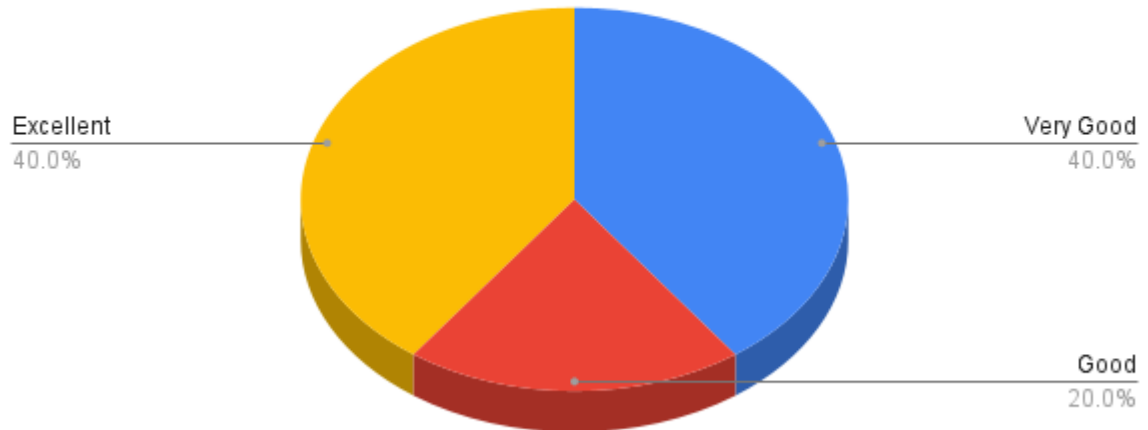


How far do you think that the curriculum helps your employees to develop team work abilities?

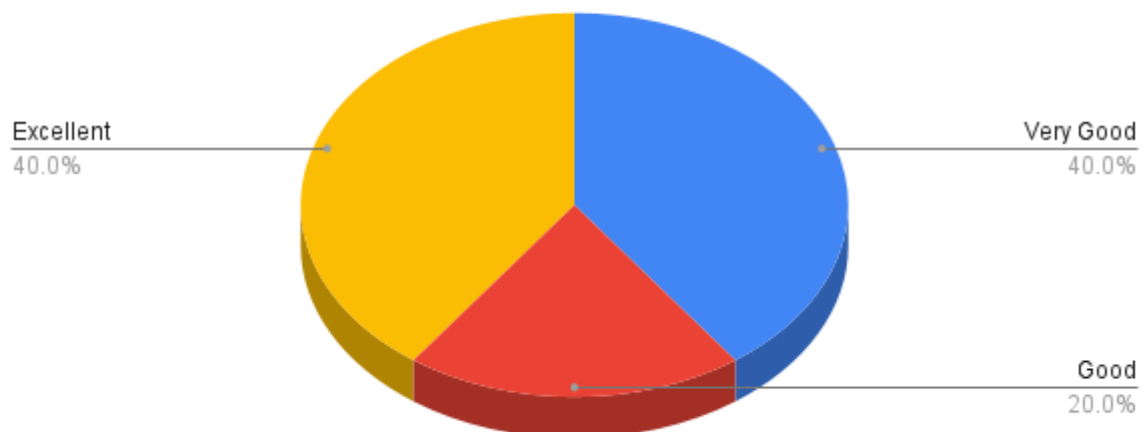




How far do you think that the curriculum help your employees to develop leadership qualities?

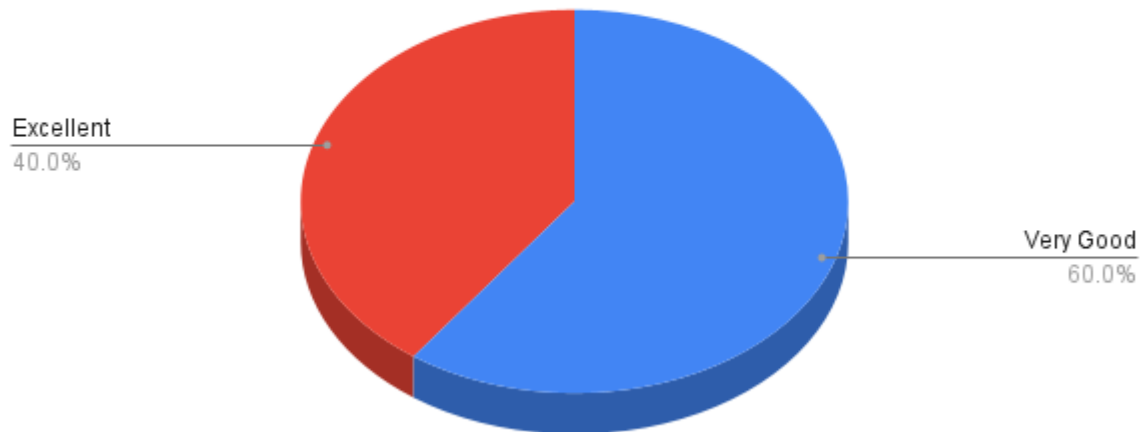


How far do you think that the curriculum ensures necessary information about professional ethics?

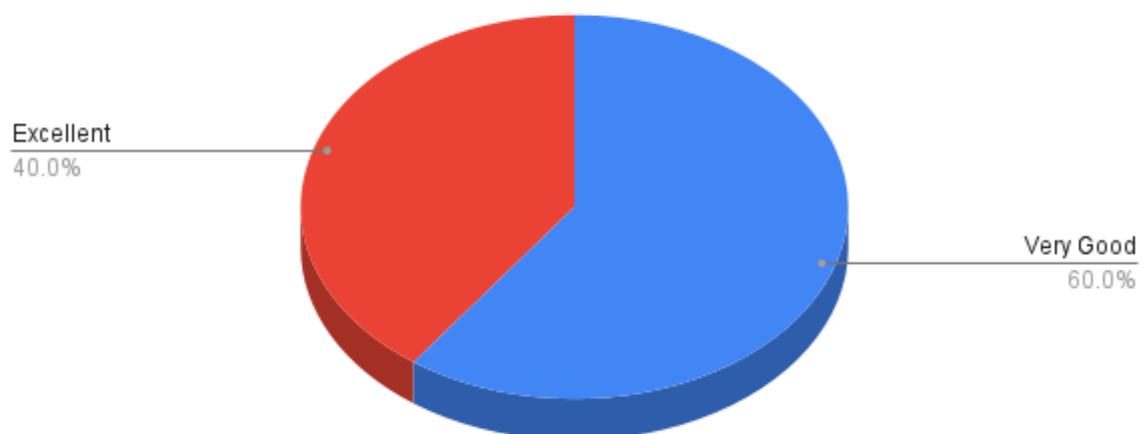


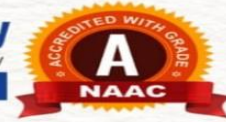


How do you rate the applicability of skill training in the curriculum in terms of existing practices in the industry?

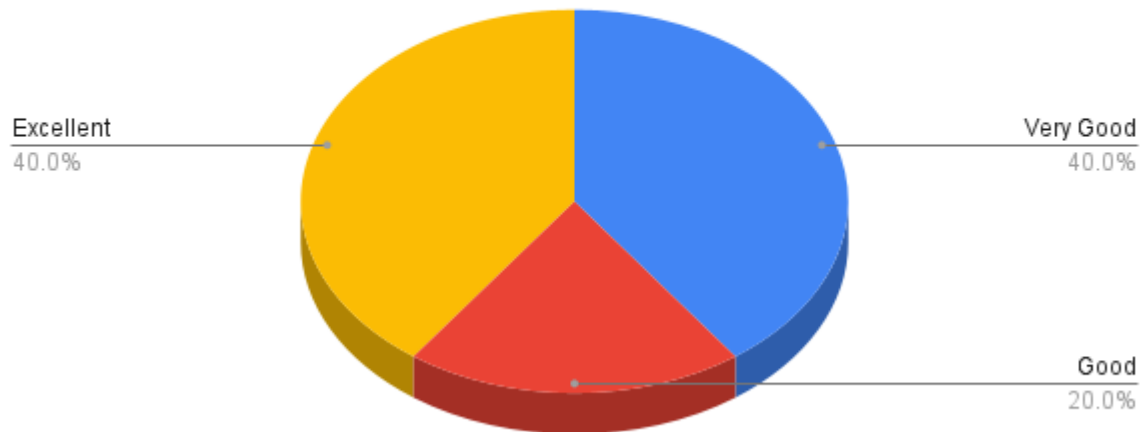
